

#### **Course Format**

This course is a hybrid course involving seated days and online days. Students are to attend seated class periods on Monday and Wednesday. Fridays will be online using assignments, tests, and content learning exercises. Students typically have the weekend to complete any Friday class work.

### **Course Requirements**

The class will include the reading of the textbooks (outside class) with follow-up assignments. All assignments will be used as a basis for the class discussion. Students will complete the following major assignments (smaller, daily work may also be assigned):

- 1. **Examinations**: There are four tests scheduled for the semester. See schedule below. These tests MUST be taken on the day scheduled or as instructed. Tests will be primarily objective: matching, multiple choice, true/false, fill-in-the-blank, and occasionally short listings and definitions. There may be some short case studies to which you will be asked to apply the legal precedents. Two tests are scheduled as online exams. Students are not allowed to collaborate on exams outside of studying together prior to the test. Online tests are also given with a time limit.
- 2. Current Events Media Law: The law is a living organism, changing on a regular and continuing basis. As media practitioners, you will need to keep current on what is happening in the field. Thus, I am requiring you to submit 3 brief reports on a current (since January 2021) media law issue. You can get these from newspapers, trade journals, Media Law Reporter, news magazines, The Reporters Committee for Freedom of the Press website <www.rcfp.org>, etc. For each one, copy or scan the original source, summarize the key legal issue in a one-page summary (single spaced) and share this with the class online. To do this, submit it online to the drop box, then post your report in the discussion board connected with that assignment. Be sure to identify the source of the clip by publication/website and date. Failure to upload and submit the report to the discussion board on the assigned date will result in lost points. There is no opportunity for make-up on this assignment. Students are then required to read three reports submitted on the discussion board and make comments by the due date.
- 3. Case Study: Each student will be assigned a key media law case to research and present to the class. In many instances, the basics of the case may be found in the text. At least 5 resources should be included and cited. Expected is an in-depth study of the case including the background of the case, the path of the case through the legal system, and the significance of the decision for media practitioners. Due dates will assigned through the semester, as the case study will be due at the time that we are covering that area in class. This should be submitted double-spaced with appropriate citations (APA or MLA) to the drop box on Canvas. An expected length would be 6 to

7 pages, not including the bibliography (which is required). The student also posts the report on the Canvas discussion board. This assignment may not be turned in late. The paper must be uploaded to the dropbox on Canvas when your deadline comes up. Once on the discussion board, other students will read and post comments as required. The author should respond to the comments with appropriate replies.

- 4. **Online Quizzes**: To help students receive credit for reading the text and keep up with the work, online quizzes are scheduled on Canvas each week on Wednesdays. The online quiz will be over the chapters covered during that particular week. Quizzes are objective and are given with a time limit. **These may not be taken late.** Check the Canvas schedule for specifics.
- 5. **Class Participation and Online Assignments**: Students receive credit for participating in class activities. Small assignments given online also contribute to the grade. See Canvas for online assignments and instructions.
- 5. **Periodic discussion threads** or assigned readings may be included in any of the weeks' requirements.

#### **TESTS**

#### **CANVAS ASSIGNMENTS AND QUIZZES**

This course incorporates the Canvas classroom software system as the basis of its curriculum. Students

are required to login to Canvas regularly to watch lectures, locate documents, take quizzes, and upload assignments. Students are advised to use a reliable computer with good Internet access whenever possible. Problems with Canvas due to incompatibility with the student's own computer or failure of Internet access to a student's computer is not cause for retaking a quiz or receiving extra time. #### **CANVAS DEFINITIONS AND ASSIGNMENT TERMS**

**Discussion Forum**. The public area or meeting place to hold a dialogue/discussion. You will create messages to post in a discussion board in order to dialogue with your classmates and the professor. Equate a discussion board to an in-class discussion.

**Dialogue**. A conversation between two or more people. It may also be thought of as an exchange of ideas or opinions on a particular issue. Dialogues exist to help you understand the material presented and apply concepts in your organization. You should use dialogues to test your understanding of every concept with your classmates and professor. Dialogue gives you the opportunity to pose questions, demonstrate your understanding of the material, and apply relevant concepts.

**Post**. A message that is sent to a group. Your posts substitute for in-class verbal contributions. Those who participate during the whole time will receive higher grades than those who "show up" only at the beginning or end of a class and make a few interjections. Those who contribute meaningful insights will receive higher grades than those who post trivial reflection. *Initial posts* are the first required student posts answering specific questions or presenting research as per assignment directions. *Response posts* are student responses to colleague posts (initial or other response posts).

As you read the material, you should highlight insights, "ah-has", and record any questions. This serves as good content to help you compose your posts. As organizational leaders, learning to write in a concise manner is a skill to gain. This means the quality of each posted message must be excellent. The forum is an academic learning environment therefore you must fully support and reference your statements. Remember the demonstrated learning and scholarship consists of supported conclusions, not just personal opinions. Extend the ideas presented by your classmates. You can expect your

professor will comment in the discussion as needed, to help guide individuals and groups toward desired learning outcomes.

The quality of your posts will be measured by several factors: (a) demonstrated comprehension of the material, (b) appropriate research material beyond the assigned readings, and (c) demonstration of critical thinking skills in applying concepts to separate personal opinion from reasoned conclusion.

Discussion post specific instructions:

- 1. All discussion posts should be in complete sentences.
- 2. Use proper grammar and punctuation.
- 3. Remember the Golden Rule, "Do unto others..." In other words, be nice!
